Re: Support for ADA Restoration Act, H.R. 3195

Dear Majority Leader Hoyer and Congressman Sensenbrenner:

When a disabled veteran recovers enough to return to the workforce, it's a slap in the face to run into employment discrimination. That is why we commend you for your leadership in sponsoring H.R. 3195 to restore the employment protections of the Americans with Disabilities Act that have been eroded by the courts.

The courts have set up a bizarre Catch-22 whereby an employer can say that a person is "too disabled" to do the job but "not disabled enough" to qualify for the employment protections of the Americans with Disabilities Act. Many employers have not hired, not promoted or fired a person because of a disability, and then they turned around and successfully argued in court that the person was not disabled under the ADA.

Contrary to clear Congressional intent, in 1999 the Supreme Court held that mitigating measures - medication, prosthetics, hearing aids, other auxiliary devices, diet and exercise or any other treatment - must be considered in determining whether an individual has a disability and is protected by the ADA. See *Sutton v. United Airlines, Inc.*, 527 U.S. 471 (1999). *Sutton* and subsequent cases expose individuals with epilepsy, diabetes, cancer, muscular dystrophy and other conditions to employment discrimination under the ADA.

Veterans often have conditions that can be managed with medication, prosthetics and therapy, including post traumatic stress disorder (PTSD), epilepsy and vision impairments from traumatic brain injuries. If they suffer employment discrimination due to their conditions, they are likely to have no remedy at law. Employers prevail in 97% of reported ADA cases alleging workplace discrimination, usually before the person has even had a chance to show whether discrimination occurred.

As leaders of organizations that represent men and women who have served honorably in our nation's military, we urge Congress to enact the ADA Restoration Act immediately. The



Again, thank you for your leadership on the ADA Restoration Act.


